M E M O R A N D U M

Subject :- Simplification of the procedure for Medical Re-imburement claim for treatment outside the State in referred cases.

In accordance with the existing provisions of C.S.(M.A.)Rules,1944, Government servants claim re-imburement of cost of medical treatment in the prescribed forms. The claims are certified in the said forms and vouchers/Money receipts are countersigned by the authorised medical attendant of the Hospital/Consulting rooms where the treatment is undertaken, as admitted under the Rules.

2. Difficulties are being experienced to obtain countersignature and certificates from doctors of the hospitals outside the State whereto the patient has been duly referred for treatment by the State Medical Board. The patient may not be able to prepare the medical claims in the prescribed form at the time of leaving the outside Hospitals to which he has been referred by the State Medical Board. On most occasions the treatment also continues even after the release from the hospital and prescribed medicines are continued to be purchased for use.

3. The Governor has therefore, been pleased to order that for simplification of the procedure for bonafide claim for re-imburement for treatment outside the State in referred cases whenever the signature and certificate of the attending

doctor of Hospital outside the State cannot be obtained in the specific form of Medical Re-imbusement Claim Form, the Doctor who refers the case, being a member of State Medical Board, for treatment outside the State, should meticulously examine the prescriptions and vouchers of the claim to satisfy himself about its correctness and genuineness and then sign the certificate in the claim Form and all relevant vouchers/money receipts etc. The claim for re-imbusement will be entertained on the basis of such certificate.

MEMORANDUM

Subject: - Reimbursement of cost of treatment for injuries caused by Extremist violence

In Finance Department's Memorandum of even number dated February 23, 1996, it had been laid down that non-gazetted employees under Group - C & D shall get reimbursement of the cost of treatment for injuries sustained in course of actual discharge of all forms of officials duties or because of extremist violence.

2. Home (Police) Deptt. has proposed that the cost of Cabin charges (AC or Non-AC) also may be borne by the Government as done for other treatment charges in relaxation of the medical attendance rules.
3. The matter has been examined and the Government recognizes the need for providing the best medical treatment to government employees including policemen sustaining injury because of the extremist violence during discharge of their duties. The Governor is pleased to decide that all the State Government employees including the Policemen sustaining injury because of extremist violence during discharge of their duties, may get benefit of free medical treatment including the tests in the highest available Class including A.C. Cabins in relaxation of the Medical Attendance Rules.
4. The Government employees will not be required to pay anything and naturally he will not be entitled to any reimbursement. The free medical treatment and non-payment of Cabin charges etc. will be subject to submission of a certificate from the Superintendent of Police or the District Magistrate of the District that injury is because of extremist violence. The Cabin facility is also subject to availability and not as a matter of entitlement.
5. However, if the case is referred to any hospital outside Tripura, the cost of treatment & tests, room charges and other incidental charges will be fully reimbursed.

MEMORANDUM

Subject :- Follow-up treatment/check-up in the referred Hospital outside the State - decision regarding approval of the State Medical Board thereof.

As per existing procedure, the approval of the State Medical Board for follow-up treatment/check-up in a recognised Government Hospital outside the State, is required, even though the patient had been referred originally by the State Medical Board to the said Hospital Outside the State and that Hospital has advised/directed the patient to visit for follow-up treatment/check-up after/within a specified period.

2. The Governor of Tripura is pleased to order that further approval of the State Medical Board shall not be necessary in case of follow-up treatment/check-up etc. in the recognised referred Hospital within 6 (six) months from the date of the first visit to that Hospital, on their prior written advice / direction, subject to the maximum of 2 (two) follow-up visits during the aforesaid period of 6 (six) months, if the patient visits without escort. However, if the escort is required to accompany the patient for the follow-up visit/treatment, it shall be necessary to obtain fresh recommendation of the State Medical Board to that effect.

3. This will take immediate effect.

MEMORANDUM

Subject :- Medical advance for the fixed pay employees for treatment outside the State.

In Finance Department's Memo. No. F.5(10)-Fin(G)/75-I dated 02-09-85 and No. F.5(2)-Fin(G)/93 dated 31-05-95 regarding grant of medical advance to the State Govt. employees, there is no mention about the admissibility of the said benefit for the employees appointed on fixed pay basis and paid from 'Salary Head'.

The Governor of Tripura is pleased to order that the Fixed Pay employees paid from 'Salary Head' shall be granted a Medical Advance equivalent to 10(ten) months' remuneration (fixed pay) or the amount as recommended by the State Medical Board or Rs.10,000/- (Rupees ten thousand only whichever is least. Since such employees are not entitled for medical reimbursement claims, the entire advance shall be recovered in 25 (twenty five) equal monthly instalments.

The advance shall only be admissible if the employee himself or member of his/her family as admissible under Rules, is referred by the State Medical Board for treatment outside the State. At the time of drawal of advance a surety bond in Form GFR-21 from a permanent government servant having status comparable to or higher than that of the fixed pay employee, shall have to be submitted. It may also be ensured that treatment has actually been undertaken outside the State as referred by the State Medical Board.

This shall come into force with immediate effect.

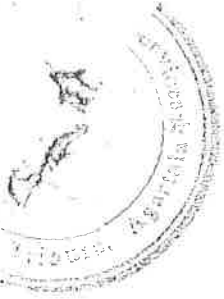

In para-3(b)(II)(Explanation) of Memo.No.F.5(10)-Fin(G)/75-I dated 2nd September,1985 and para-2 of Memo.No.-F.5(10)-Fin(G)/75 dated 19-11-1975, regarding re-imbusement of medical treatment outside the State, it has been stated that, in case of married female government servant the term "Family" will include interalia the parents-in-law and not the father and mother of such female government servant.

2. In partial modification of above Memos., the Governor of Tripura is pleased to order that the female government servants would be given a choice to include either her parents or her parents-in-law in family for the benefit of Medical reimbursement.

3. Every female government employee should immediately after her marriage give a declaration as to whether she w should like to include her parents or parents-in-law in her family for the purpose of availing of the benefits of medical advance scheme. She can change her option only once during the entire period of her service.

4. In the event both husband and wife are government employees the benefit would be available to only one member.

5. Other conditions in the above Memos. dated 2nd September,1985 and 19th November,1975 shall remain unchanged.

Subject :- Medical Reimbursement facility to Group-'C' & 'D' Government employees for treatment as referred case outside the State and also for treatment of Cancer in the Cancer hospital of the State.

Consequent upon issue of G.O. No.8 dated 25-9-2004 from the file No.2(10-23A)/MS/Estt/MR/2002 (Part-III) of the Health & Family Welfare Department, a considerable number of cases are referred to the Finance Department from various Departments seeking concurrence/approval regarding admissibility of claims of medical reimbursement facilities of Group-C & D category of employees as cases of special dispensation even when the cases are referred by the State Medical Board in terms of para(f) of the said memo. On the other hand, certain clarifications were issued in the past from the Finance Department about admissibility of medical reimbursement claim of Group-C & D employees under a few special exigencies.

2. Now it is felt that for quick disposal of the claims of medical reimbursement of Group-C & D employees admissible under aforesaid G.O. and circulars issued from the Finance Department, certain clarifications need to be issued. Accordingly, the undersigned is directed to issue following clarifications to facilitate quick disposal of the medical reimbursement claims of Group-C & D employees and for removing the ambiguities:-

A.(i) When a Group-C / Group-D Government employee himself / herself suffering from disease other than cancer is referred to Medical Institution / Hospital to which he / she is referred to, the cost of treatment in that Institution / Hospital excluding the cost of journey is admissible for reimbursement. This benefit is not admissible in respect of any member of the family of such a Government employee.

(ii) When a Group-C / Group-D Government employee himself / herself or any member of his/her family suffers from cancer and is referred to a medical Institution/Hospital outside the State by the Standing Medical Board, the cost of treatment in such Institution / Hospital inclusive of admissible journey expenses only up to referred Institution / hospital (both ways) is admissible for reimbursement. Journey expenses of the escort, if any recommended by the Standing Medical Board, is also admissible for reimbursement.

(iii) Group-C /Group-D Government employee shall continue reimbursement of the cost of treatment of cancer for him/herself and his/ her members of the family for treatment in Cancer Hospital in the State vide Memo No.F.5(2)-FIN(G)/93 dated 14.06.1996(Annexure-I).

B. The reimbursement facility for implanting of pacemaker as provided in Memo No.5(2)-FIN(G)/93 dated 26.02.1996 (Annexure-II) and No.F.5(2)-FIN(G)/93 dated 24.05.1997 (Annexure-III) for Group-'C' & 'D' employees shall continue to be admissible, subject to limit fixed therein.

C. The reimbursement facility for injuries caused by extremist violence or injury sustained in course of discharge of official duties for Group-'C' & 'D' employees as provided in Memo No.F.11(1)-FIN(G)/94 dated 23.02.1996 (Annexure-IV), Memo of even No.18.03.1996(Annexure-V) and 07.06.1997(Annexure-VI) shall also continue to be admissible.

Subject: Medical Reimbursement facility to Group-C and Group-D Government employees for treatment as referred case outside the State - clarification thereof

The undersigned is directed to refer to the Memorandum NO.F. 5(10)-FIN(G)/75(L) dated 1-8-2007 of the Finance Department under which it was clarified that whenever a Group-C or Group-D employee duly referred by Standing Medical Board to a particular Institution/Hospital for medical treatment but undertakes the treatment at some other Institution/Hospital of his/her own choice/volition, he/she shall be entitled to get medical re-imburement which shall be limited to the treatment cost at rates of the referred medical Institution/Hospital including journey expenses for the purpose as per existing TA Rules.

2. After issue of the above Memorandum, several references received from different Departments seeking clarification how journey expense admissibility would be determined for aforesaid category of patients referred by the State Medical Board for treatment outside the State.

3. After careful consideration of the entire issue, it is hereby clarified that subject to other conditions contained in the aforesaid Memorandum, the admissible journey expenses will only cover fare from place of headquarter of the referred employee to the place of referred Hospital/Health Institution through shortest route under mode of journey which the concerned employee is admissible under TA Rules of the Government of Tripura on the basis of his/her Pay scale and Basic Pay range. No other claim/expenses would be admissible as 'journey expenses' for reimbursement.







ORDER

Group-A & B officials of State Government are entitled to medical reimbursement facility for the treatment outside the State on being referred by the Standing Medical Board. As per Central Service (MA) Rules 1944 (adopted by the Government of Tripura) families of the State Government Group-A & B officials are also entitled to this facility.

2. Finance Department, Govt. of Tripura vide its Memorandum No. F. 30(1)-FIN (G)/06 dated 20 October 2011 (p-2c) has mentioned that there is need to regulate cases where family members of State Government Group-A & B servants, are not residing with the concerned government servant but staying outside the State and they have no scope to get referred by the State Medical Board to the medical institutions recognized by State Government for medical treatment.

3. The matter regarding extension of medical reimbursement to the family members of Group-A & Group-B officials who are residing with the concerned government servants in Tripura but staying outside the State was under consideration of the State Government for some time. Apart from this, extension of medical reimbursement facility to employees posted in Tripura Bhavan at Guwahati, Kolkata and New Delhi also had been under consideration.

4. After careful examination of the matter, it has been decided to lay down the following guidelines in this regard:

- a) Group-A & B officials will be entitled to medical reimbursement for their family members residing outside the State as per G.O. No.8 dated 25.9.2004 and G.O.No.2 dated 30.8.2007 when any treatment is undertaken in any of the empanelled Hospitals.
- b) In case treatment is done in any other Hospital due to non-availability of empanelled Hospital at the station where family member (s) of the concerned government servant is staying, medical reimbursement will be admissible as per rate of SSKM Hospital, Kolkata or the actual cost of treatment, whichever is lower.
- c) In case of government employees who are entitled to medical reimbursement and are posted in Tripura Bhavan at Guwahati, Kolkata and New Delhi, reimbursement of treatment cost in empanelled hospitals will be admissible as per G.O.s referred to above. If such treatment is undertaken at any other Hospital which is not empanelled, the employee concerned will be eligible to get reimbursement of treatment expenses at the rate of any Government Hospital at Guwahati, Kolkata and New Delhi or the actual cost of treatment, whichever is lower. The entitled government employee may take treatment as per advice of medical

officer attached to any Tripura Bhawan. However, the reimbursement will be done as per normal rules.

5. Consequent upon the above clarifications, administrative departments under the Government of Tripura shall not be required to refer cases either to Health & Family Welfare Department or to Finance Department seeking views on admissibility.

6. This order is issued with concurrence of Finance Department vide No.5705/Com/Fin/2011, dated 5 December 2011 and shall take immediate effect.

NOTIFICATION

Issues relating to various operational difficulties in implementing guidelines contained in G.O. 08, dated 25-09-2004 had been brought to our attention and then were examined by the Health & Family Welfare Department in consultation with concerned Departments. Now the Governor, Tripura is pleased to lay down following guidelines with regard to admissibility of medical reimbursement expenses to State Government Officials for treatment outside the State on being referred by the Standing Medical Board.

- a) The Standing Medical Board is required from time to time to refer patients outside the State for treatment / investigation(s) of various ailments for which facilities do not exist here and in such situations, the Standing Medical Board shall refer patients only to the following Medical institutions :
1. SSKM Hospital, Kolkata
 2. Institute of Post Graduate Medical Education & Research, Kolkata
 3. School of Tropical Medicine, Kolkata
 4. Cancer Centre and Welfare Home, Thakurpukur, Kolkata
 5. Silchar Medical College & Hospital
 6. Sankar Deva Netralaya, Guwahati
 7. CMC Hospital, Vellore
 8. Care Hospital, Hyderabad
 9. National Institute of Mental Health & Neuroscience, Bangalore
 10. AIIMS, New Delhi.
- b) Group-A and Group-B Officials when referred by the Standing Medical Board to the listed institutions shall be eligible to get medical reimbursement for treatment/ investigation(s) undertaken at rates of the referred institutions. They will also be entitled to get reimbursement of traveling expenses as per existing pattern.
- c) In cases where the above category of officials do not undertake treatment/ investigations at the referred institutions and instead receives treatment / undergoes investigations for which referral was made, at an health institution of their own choice at any place, treatment / investigation(s) expenses shall be reimbursed at the rate fixed by the hospital to which referral was made or the actual treatment / investigation expenses whichever is lower. They will be entitled to get traveling expenses also as per existing pattern but up to the referred institute only; which ever is lower.

- d) When Cancer patients referred by the State Medical Board for treatment investigation to the Cancer Centre and Welfare Home, Thakurpukur, Kolkata receive treatment/ investigation at any other Cancer treatment institution of their own choice, treatment/investigation expenses shall be reimbursed at the rate fixed by CC& WH, Thakurpukur, Kolkata or the actual treatment /investigation expenses, whichever is lower. They will be entitled to get reimbursement of traveling expenses also as per existing pattern but in the referred institute only.
- e) In case of Government employee who is entitled to medical reimburs facility, while being outside normal duty station in connection with c works, requires medical treatment, he would be eligible to obtain it a nearest health institution where he fell ill and will be eligible to reimbursement of treatment expenses at the rate fixed by SSKM Hosp. Kolkata or the actual treatment expenses, whichever is lower.
- f) This order shall take immediate effect and is issued in supersession of G. No. 08, dated 25-09-2004 [File No. 2(10-23A)-MS/Estt/MR/2002 (P-III)] also in suitable modifications of instructions issued by the Health & Farni Welfare Department, Government of Tripura in this regard from time to time.

The Governor of Tripura is pleased to amend the guidelines of THASP in the following manner:-

1. In order to offer option to patients and cover a diverse range of hospitals with better facilities following guidelines are included as follows with immediate effect.

- (1) A single list of referral hospitals both for Government employees and for the scheme.
- (2) Hospitals which have entered into MOU or consented to the scheme guidelines with the Health & Family Welfare Department will be reimbursed as per the scheme directly to them as is being done now.
- (3) The hospitals which have not entered into MOU but if the patient is referred by the Standing Medical Board to them, patients will be reimbursed the cost of procedures as per the scheme guidelines as being done in case of referred Govt. employees
- (4) If a patient is treated in a different super specialist hospital than the one referred to, the patient will be reimbursed the specific cost of procedures of the nearest referred hospital but not the cost of hospital in which the patient was treated, if it is higher.
- (5) The Income Certificate of appointing authority will be considered sufficient in case of employees / workers engaged by agencies / departments of the State Government.







If any doubt arises in issuance of referral certificate, any member of the Standing Medical Board is at liberty to verify the genuineness of the case by physical verification.

5. ILS Hospitals should enter into an agreement and also undertake not to charge higher than approved rates from the referred patients.

6. This order shall take immediate effect and is issued in supersession of G.O. No. 303/RT/2014, dated 31-05-2014 and 203/RT/2013, dated 19-09-2013 [File No. 2(10-43A)-DHS/Estt/MR/2012] as also in suitable modifications of instructions issued by the Health & Family Welfare Department, Government of Tripura in this regard from time to time.


