

**MEMORANDUM**

Subject: -Extension of period for submission of Life Certificate By State Government Pensioners till **February 28, 2021.**

The undersigned is directed to refer to Department of Pension & Pensioner's Welfare, Public Grievances & Pension, Ministry of Personnel, Government of India, O.M.No.18/1/2020-P&PW(H)-Vol-III-6786 dated 23.11.2020 regarding extension of period of submission of Life Certificate by Central Government Pensioners till February 28,2021 and to say that a similar matter was under examination in Finance Department for quite some time. After careful examination of the matter and in view of the ongoing Covid-19 pandemic and the vulnerability of elderly population to Corona Virus, it has been decided to extend the existing timeline for submission of Life Certificate till **28<sup>th</sup> February, 2021.** During this extension period, the pension will be continued to be paid by the Pension Disbursing Authorities (PDAs) uninterrupted.

2. In light of the above, the undersigned has been directed to inform all Pension Disbursing Authorities to take note of this Memorandum for compliance and to give wide publicity to the same amongst the Pensioners.


