NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tripura is pleased to make the following Rules to further amend the Tripura State Civil Services (Revised Pay) Rules, 2009 (hereinafter referred to as the 'Principal Rules'), namely:

1] Short title and commencement :

- i) These Rules may be called the 'Tripura State Civil Services (Revised Pay) (Tenth Amendment) Rules, 2014';
- ii) They shall come into force on and from the 1st day of January, 2006.


2] Amendment of Rule 14 of the Principal Rules :

After sub-rule (10) of Rule 14 of the Principal Rules issued vide Notification No.F.6(1)-FIN(PC)/2008 dated 7 January 2013, a new sub-rule '(10A)' shall be inserted as below :

“(10A) Modification of pay scale of the post of Junior Pharmacist under Education (Higher) Department :

Education (Higher) Department shall amend the Recruitment Rules of the post accordingly. Pay of the concerned Pharmacists shall be re-fixed as per modified grades of the post in the revised pay structure of Pay Band plus Grade Pay w.e.f. 01-01-2006 or on the date of option already exercised for coming over to the revised pay structure under the rules and thereafter, notionally regulated under normal rules up to the period prior to the date of issue of amendment to the Recruitment Rules of the post. The financial benefit on the above modification of grades of post in the revised pay structure of Pay Band plus Grade Pay, if any, shall be payable with effect from the date of issue of the amended Recruitment Rules.
