MEMORANDUM


Subject:- Valid documents for determining the date of birth in respect of family pensioners.

As per provision under Sub Rule (i) of Rule 7 of TSCS (Revised Pension) Rules, family pensioners who have attained the age of 80 years or above is granted with additional quantum of pension . Recently, communication has been received from Office of Accountant General , Tripura informing that though the date of birth of a pensioner is mentioned in the Pension Payment Order (PPO) of the concerned pensioner but the date of birth is not available in the PPO of the pensioner. Due to this, it is difficult to assess the age of the family pensioner for ascertaining his/ her eligibility towards additional quantum of pension. Hence, it has been requested to indicate alternate documents that could be treated as valid documents to prove the age of family pensioner.

2. The matter has been examined in Finance Department . Upon careful examination of matter it has been decided that the following documents may be treated as valid for establishing the identity as well as date of birth of the family pensioner:- .

1. Policy Bond issued by Public Life Insurance Corporation/Company.
2. Aadhar Card/ E- Aadhar.
3. Service record copy (Government servant)
4. EPIC Card of Election Commission of India.
5. PAN Card/ Driving license of Competent authority
6. Permanent Resident of Tripura Certificate.

3. In view of the above, the undersigned has been directed to request all concerned to arrange for bringing the above to the notice of all Pensioner/ Family Pensioner.
