**NOTIFICATION**

**Subject: Delegation of Financial Powers Rules, Tripura, 2017 - Amendment thereof.**

**1] Short title and commencement:**

- (i) These may be called the 'Delegation of Financial Powers Rules, Tripura, 2017 (**Third Amendment**)'.
- (ii) They shall come into force on and from the date of issue of notification.

**2]** In pursuance of Clause 3 of Article 166 of the Constitution of India and all power enabling in this behalf and also due to merger of Plan and Non-Plan Heads, the Governor of Tripura is pleased to direct that the following amendments have been made in the below mentioned Rules under Delegation of Financial Power Rules, Tripura, 2017:
