The undersigned is directed to inform that Collection of Tripura Road Development Cess shall be utilized for the Development of Roads of the State.

As per Section 4 of Tripura Development Cess Act, 2018 and communication received from Office of the Pr. A.G. (A&E), Tripura, Tripura Road Development Cess shall be transferred from the Consolidated Fund of the state to a separate non-interest bearing Reserve fund under Public Account through Revenue Expenditure head of account.
