MEMORANDUM

Sub:- Guidelines for drawl of arrears of Government and Employee Contribution towards NPS for AIS Officers.

The following procedure will be followed for drawl of arrears of Government and Employee Contribution under NPS.

- 2. The State Nodal Officer, Finance Department, Government of Tripura will issue a statement of Basic Pay, Dearness Allowance and State Govt. contribution of each member of service who are covered under NPS to the TO/DDO concerned.
- 3. In addition, simple interest compounded on annual basis on the lines of GPF will be provided for the unpaid arrears of NPS. The interest will be calculated only from the month next to the month in which officer joined in the State i.e. Tripura. The rate of interest will be same as that applicable for GPF during the relevant time. The payment of interest will be till December 2013 as a one time measure on Govt. Contribution.
- 4. The DDO will draw two Book Transfer (BT) bills one for the whole amount of arrears of Government Contribution and second bill for total interest as calculated above. The amount so drawn will be shown as recoveries in favour of concerned Treasury Officer/Sub-Treasury Officer. Thereafter the Treasury Officer will draw the said amount and transfer to the State Nodal Officer.
- 5. The procedure for drawl of arrears of State Government's contribution and transfer to the Subscriber's NPS account will be same as that prescribed in the guidelines issued vide F.D. Memorandum No. F. 58(03)-FIN(B)/2013/36869-37068 dated 4th November 2013. The procedure for uploading of

legacy data and transfer of fund to the Trustee Bank will also be same as mentioned in these guidelines.

- 6. The arrears of Employee Contribution (@ 10% of (Basic Pay + DA) shall be deposited by the member concerned in one instalment to the DDO who in turn will deposit the amount through Challan in favour of related Treasury Officer. The Treasury Officer and State Nodal Officer will follow same procedure for transfer of the Arrears of Employee Contribution to the Subscriber's NPS account as mentioned above. No interest will be payable in case of Employee contribution.
- 7. The SNO will ensure that the legacy data is uploaded in the NSDL website in favour of the Officer concerned correctly and timely.
