## MEMORANDUM

**Subject:**-Travelling Allowance -- Modification thereof.

In partial modification of this Department's earlier instructions issued in this regard, the Governor of Tripura has been pleased to order the revision of the existing rates of conveyance allowances for journey on tour or on official duty , performed by taking a single seat, within destinations as mentioned below:-

(a) Car/Taxi fare between IGI Airport, New Delhi and Tripura Bhawan, New Delhi and vice-versa

Rs. 700/- or the actual fare, whichever is less

(b) Car/Taxi fare between NSCB Airport, Kolkata and Tripura Bhawan, Kolkata and vice-versa Rs. 500/- or the actual fare, whichever is less

(c) Car/Taxi fare between LGB Airport Guwahati and Tripura Bhawan, Guwahati and vice-versa

Rs. 400/- or the actual fare, whichever is less

(d) Car/ Auto-rickshaw Fare between Agartala Airport and Agartala Town and vice-versa

Rs. 200/- or the actual fare, whichever is less

- 2. In respect of destinations not mentioned above, the revised rates of conveyance charges, for journey on tour or on official duty, performed by taking a single seat, shall be as follows:-
- Wherever for destinations for which rates of Transport Department of the concerned State is available, those rates or the actual fare, whichever is less, shall be applicable;
- For destinations where no specific rates have been prescribed by the Transport
  Department of the concerned State, the rates prescribed by Transport Department,
  Government of Tripura for equivalent mileage or the actual fare, whichever is less, shall
  be applicable.
