MEMORANDUM

Sub:- Revision of pay of employees and workers of Autonomous Bodies/ PSUs/ Cooperative Banks/ Agencies/ Societies and similar organizations of the State.

Based on the recommendations of the Expert Committee, the State Government has decided to implement the revision of pay for its employees from 1st day of October, 2018.

- 2. Regarding employees and workers of Autonomous Bodies/ PSUs/ Cooperative Banks/ Agencies/ Societies and similar organizations, it is stated that most of these Organisations are of commercial nature and are expected to generate resources for meeting their expenditure including the liabilities on account of salaries, wages, etc. However, barring a few Organisations, others have been incurring losses and are dependent on the State Government for their funding, fully or partially. Thus, any further revision of pay will involve increase in burden on State Exchequer.
- 3. In view the above, it has been decided that wherever revision of pay and wages of employees and workers of Autonomous Bodies/ PSUs/ Cooperative Banks/ Agencies/ Societies and similar organizations is intended, the respective administrative department shall examine the proposal in details in consultation with the concerned organization; specifically with respect to financial resource position of the concerned Autonomous Bodies/ PSUs/ Cooperative Banks/ Agencies/ Societies etc., and thereafter initiate proposal to Finance Department for further consideration. After examination of the proposal in Finance Department, the matter shall be decided with the approval of the Council of Ministers.
