MEMORANDUM

Subject:- 6th CPC recommendations -- Revised rates of Special Compensatory (Remote Locality) Allowance for AIS Officers and Central Government Employees deputed in Tripura on account of revision of Dearness Allowances beyond 150%.

The State Government has adopted 7th CPC recommendations on grant of Tough Location Allowance as issued by the Government of India, Ministry of Finance, Department of Expenditure, O.M. No.3/1/2017-E.II(B) dt.19.07.2017. Para-8 of the said Memorandum indicates that employees have the option for continuing Special Compensatory (Remote Locality) Allowance at old rate of 6th CPC, where it was admissible, along with Special Duty Allowance at revised rate of 10% of basic pay. The pre-revised rate of Special Compensatory (Remote Locality) Allowance as per O.M. No. 3(1)/2008-E.II(B) dt.29.08.2008 issued by Government of India, Ministry of Finance, Department of Expenditure is as given below:-

Category	Part B (Rs. p.m.)	Part C (Rs. p.m.)
For posts in the grade pay of Rs.5400/- and above and pay scale of HAG+ and above	2100	1500
For posts in the grade pay less than Rs.5400/-	1600	1200

2. O.M. dated 29.08.2008 also states that the rate of Special Compensatory Allowance shall automatically increase by 25% whenever the Dearness Allowance payable under 6th CPC regime goes up by 50%. Vide O.M. No. 1/3(1)-2008-E.II(B) dt.13.08.2021 issued by Government of India, Ministry of Finance, Department of Expenditure, the rate of Dearness Allowance has crossed to 154% of basic pay under 6th CPC period w.e.f. 01.01.2019. O.M. dated 13.08.2021 has been adopted by the State Government vide Memorandum No. F.5(6)-FIN(G)/79(P-II) dated 28-05-2019.

3. In view of the above, the undersigned is directed to inform that the Governor is pleased to decide that based on the rate of Dearness Allowance as applicable to AIS Officers and Central Government employees retaining the Grade Pay structure as per 6th CPC regime, the Special Compensatory (Remote Locality) Allowance to the AIS Officers and Central Government employees serving in the State of Tripura shall be allowed at following rates w.e.f. 01.01.2019 :-

Category	Part B (Rs.p.m.)	Part C (Rs.p.m.)
For posts in the Pay Level 10 and above under 7 th CPC Pay Matrix (pre-revised grade pay of Rs.5400/- and above and pay scale of HAG+ and above)	3675	2625
For posts in the Pay Level 9 and below under 7 th CPC Pay Matrix (pre-revised Grade Pay less than Rs.5400/-)	2800	2100

4. Concerned establishment may take suitable action for payment of Special Compensatory (Remote Locality) Allowance accordingly to the eligible employees.
