## NOTIFICATION

In exercise of the power conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tripura in consultation with the Tripura Public Service Commission is pleased to make the following rules regulating the method of recruitment to the post of 'Assistant System Engineer' in the Directorate of Treasuries under the Finance Department, namely:

# 1. Short title and commencement:

- i) These rules may be called the 'Recruitment Rules, 2016' for the post of 'Assistant System Engineer' in the Directorate of Treasuries under the Finance Department.
- ii) They shall come into force on and from the date of their publication in the official Gazette.

## 2. Name of the post:

The name of the post(s) shall be as specified in Column – 1 of the Schedule annexed hereto.

# 3. Number, classification and scale of pay:

The number of the post(s), its classification and scale of pay attached thereto shall be as specified in Column – 2 to 4 of the Schedule annexed hereto.

# 4. Method of recruitment, age limit, qualification etc. :

The method of recruitment to the said post(s), age limit, qualification and other matters relating to the said post(s) shall be as specified in Column – 5 to 13 of the Schedule annexed hereto.

# 5. Disqualification: No person,

- i) who has entered into or contracted a marriage with a person having spouse living,
- ii) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post.

Provided that the State Government may, if satisfied that such a marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

#### Power to relax: 6.

Where the State Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing and in consultation with the Tripura Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

#### Saving: 7.

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided to candidates belonging to the Scheduled Castes, Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the State Government from time to time in this regard.

#### Interpretation: 8.

If any question arises relating to the interpretation of these rules, it shall be referred to the Finance Department, Government of Tripura, whose decision thereon shall be final.
