As per this memorandum, Group-C & Group-D State government employees may also avail the facility under aforementioned health insurance scheme after surrendering the existing medical allowance facilities.

Sub: Action Plan for CM JAY 2023 Card Generation

The Chief Minister Jan Arogya Yojana (CM JAY) 2023, a public health insurance scheme modelled upon AB-PMJAY and being fully funded by Government of Tripura, was launched on 15th Feb 2024 by the Hon'ble Chief Minister, Tripura at Agartala. The scheme would provide benefits similar to those offered under AB-PMJAY, including at the same empanelled healthcare providers (EHCP). Left-out families of the state, i.e. families which do not fall under the eligibility criteria of AB-PMJAY, BoCW (Building and Other Construction Workers) welfare scheme and PM JANMAN scheme would be eligible to get benefit under CM JAY 2023. Also, CAPF personnel would not be allowed to avail any benefit under the scheme. State government employees (entire family) who would surrender the extant Medical Reimbursement (Group A and B) and Medical Allowance (Group C and D) facilities shall be allowed to be a beneficiary under the scheme.

Now, to rollout the scheme throughout the state, it has been decided to launch a special drive under the aegis of District Administration for CM JAY 2023 card generation involving the District Administration, Health Department, other state government departments, CSC e-Governance Service Network and other possible stakeholders. To implement the same, the following roadmap may be followed :

1] **GP/VC-wise Camps**

The concerned Community Health Officer (CHO) and ASHAs to mobilise residents. The Rural Programme Managers (RPMs) to generate CM JAY 2023 cards. A suitable location may be selected having decent internet connectivity. Prior miking may be undertaken by local authorities about the date-time-venue as well as asking beneficiaries to bring AADHAAR and Ration Cards. 1 camp/village/week shall be held for next 3 weeks, from 19 February – 10 March 2024. It shall be attempted to handover as many CM JAY 2023 cards (paper cards) as possible at the camp. In case of difficulties in distributing paper cards, the soft copy of the cards too can be shared with the concerned beneficiaries via WhatsApp etc. The paper cards which cannot be distributed on site shall be handed over to the concerned families within 5 days by

the local ASHAs with register-based acknowledgement/receipt. Concerned BDOs and MOICs to provide all required support.

CHOs and RPMs to ensure cross checking of eligibility of the beneficiaries under AB-PMJAY as well.

BDOs to contact Mr. Bijan Datta, IT-cum-Data Manager, THPS, AB-PMJAY (7005614898) for generation of Operator ID for Rural Programme Managers.

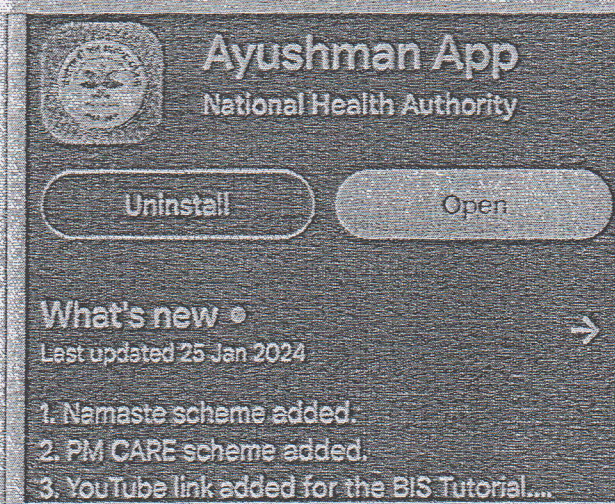
CHOs and RPMs to share the list of beneficiaries not having AADHAAR Cards with the concerned BDOs once in a month for generation of AADHAAR Cards, without which the beneficiaries cannot avail Ayushman / CM JAY cards.

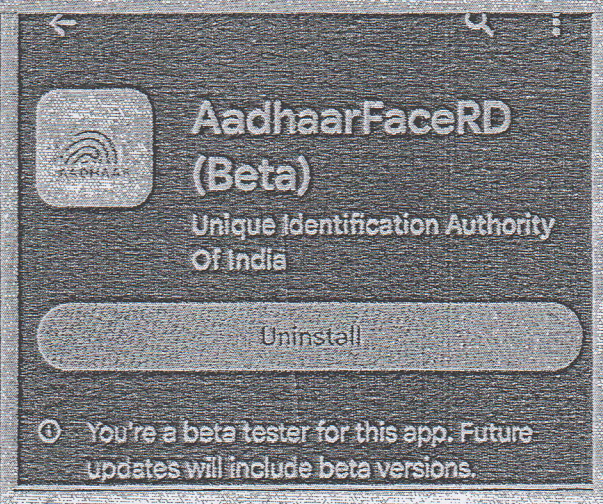
2] Publicity of Self-generation Feature in Ayushman App

The Ayushman App, available to download from Google Play Store, provides the facility to self generate both Ayushman Card and CM JAY 2023 card through AADHAAR OTP (AADHAAR-linked mobile number required) / Face Authentication / Fingerprint / Iris Scan. An eligible person can conveniently generate his/her card by using any of the options. Therefore, taking into consideration all practicalities, the AADHAAR OTP and Face Authentication based card generation methods must be vigorously publicised by ASHAs, CHOs, Anganwadi Workers, TRLM field personnel, RPMS and other similar field functionaries.

For using the Face Authentication feature through Smartphone, the AadhaarFaceRD (Image 2) App shall be downloaded from Google Play Store along with the Ayushman App (Image 1) first.

3] Walk-in Beneficiaries at Hospitals

All existing AB-PMJAY help desks may be used to generate CM JAY cards too, provided regular PM-JAY processes are not hampered. General OPD registration counters at hospitals too shall be used for CM JAY card generation. PM-JAY help desks at PHCs and CHCs to be fully utilised for CM JAY card generation. The cards thus generated shall be handed over to the beneficiaries on spot. In case cards are not generated instantly, those may be delivered to the concerned beneficiaries by the ASHAs, MPWs and CHOs within 5 days.

4] Strategy for Urban Areas

Under Agartala Municipal Corporation, other Municipal Councils and Nagar Panchayats, all Wards shall have 1 card generation camp / week for the next 3 weeks from 19 February – 10 March 2024. All Ward Secretaries, CHOs and ASHAs to mobilise public for the camp. Ward functionaries would be generating CM JAY 2023 cards on spot. Prior miking/IEC to be undertaken by concerned Ward. The same may be monitored by AMC/other Urban Local bodies. The cards which cannot be delivered on spot shall be delivered to the beneficiaries by ASHAs/MPWs/CHOs/Ward Functionaries within 5 days.
