Subject :- Enhancement of wages/ remuneration of Fixed Pay employees (engaged against fixed pay posts created by keeping regular pay scale post in abeyance), DRWs/MRWs/Contingent Workers/Casual Workers/Part-time Workers (engaged against posts created with concurrence and without concurrence of Finance Department), Permanent Labourers, Persons working in Public Places of Worship (Head Priest, Adhikari, Priest/Chantai/Principal/Chandi Pathak/ Cook/ Pujari, Tallua/ Mali/ Guard/Singer/Sweeper/Gardener), Village Chawkidar, School Mother, Adult Literacy Teacher, Part-time Instructor, Community Health Guide, Home Guards etc., **w.e.f. 01.10.2025.**

The undersigned is directed to refer to the subject captioned above and to state that the Governor of Tripura is pleased to decide enhancement of wages/remuneration of existing Fixed Pay employees (engaged against fixed pay posts created by keeping regular pay scale post in abeyance), DRWs/MRWs/Contingent Workers/Casual Workers/Part-time Workers (engaged against posts created with concurrence and without concurrence of Finance Department), Permanent Labourers, Persons working in Public Places of Worship (Head Priest, Adhikari, Priest/Chantai/Principal/Chandi Pathak/ Cook/ Pujari, Tallua/ Mali/ Guard/Singer/Sweeper/Gardener), Village Chawkidar, School Mother, Adult Literacy Teacher, Part-time Instructor, Community Health Guide, Home Guards etc., **w.e.f. 01.10.2025** which are as follows :-

2. The monthly remuneration of Fixed Pay employees (who have been engaged against fixed pay posts created by keeping regular scale post in abeyance) will be enhanced by further 3% over the fixed remuneration (i.e 75% of the entry Level pay in which the person was appointed) w.e.f. **01.10.2025**. With the release of this installment at the rate of 3%, total enhancement shall now stand at 36% (33% + 3%) over the fixed remuneration (i.e 75% of the entry Level pay in which the person was appointed) with effect from **01.10.2025**. Grant of enhancement shall not be taken together with the basic fixed remuneration for determination of minimum basic pay of the aforesaid category of fixed pay employees, at the time of the regularization of pay. This rate shall, however, not be applicable to employees engaged on consolidated monthly wages/remuneration.
