Subject:- **Revision of rates of monthly honorarium of Anganwadi Workers and Anganwadi Helpers under the Tripura State Civil Service (Revised Pay) Rules, 2017.**

The Governor of Tripura is pleased to order that the existing rates of monthly honorarium of Anganwadi Workers and Anganwadi Helpers shall be revised with effect from 1st day of April, 2017 as follows:-

2. For ICDS Workers (Central), the rate of State contribution of honorarium would be increased by Rs.210/- (Rupees two hundred and ten) only per month over the existing rate with effect from 1st day of April, 2017 or from the date of joining, whichever is later.

3. For ICDS Helper (Central), the rate of State contribution of honorarium would be increased by Rs.130/- (Rupees One hundred and thirty) only per month over the existing rate with effect from 1st day of April, 2017 or from the date of joining, whichever is later.
