
MEMORANDUM

Subject:- Payment of Dearness Allowance to the Central Government Employees under 7<sup>th</sup> Central Pay Commission – Revised Rates effective from 01-07-2022

The undersigned is directed to enclose herewith a copy of the Office Memorandum No. 1/3/2022-E-II(B), dated the 3<sup>rd</sup> October, 2022 of the Ministry of Finance, Department of Expenditure, Government of India regarding payment of Dearness Allowances(DA) to the Central Government employees as revised rates effective from 01-07-2022 and mode of payment thereof.

All Heads of Departments/Head of Offices are, therefore, requested to arrange payment of DA at the rate from the existing of 34% to 38% of Basic Pay per month w.e.f. 01-07-2022 to the All India Services Officers of Tripura cadre and other Central Government employees working on deputation under the State Government of Tripura in terms of Rule-3 of the AIS (DA Rules 1972) subject to the terms and conditions laid down in the GOI office memo. referred to above.



OFFICE MEMORANDUM

Subject: Revision of rates of Dearness Allowance to Central Government employees-effective from 01.07.2022.

The undersigned is directed to refer to this Ministry's Office Memorandum No. 1/2/2022-E-II (B) dated 31.03.2022 on the subject mentioned above and to say that the President is pleased to decide that the rate of Dearness Allowance payable to Central Government employees, shall be enhanced from **34% to 38% of the Basic Pay with effect from 1<sup>st</sup> July, 2022.**

2. The term 'Basic Pay' in the revised pay structure means the pay drawn in the prescribed Level in the Pay Matrix as per 7<sup>th</sup> CPC recommendations accepted by the Government, but does not include any other type of pay like special pay, etc.
3. The Dearness Allowance will continue to be a distinct element of remuneration and will not be treated as pay within the ambit of FR 9(21).
4. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
5. These orders shall also apply to the civilian employees paid from the Defence Services Estimates and the expenditure will be chargeable to the relevant head of the Defence Services Estimates. In respect of Armed Forces personnel and Railway employees, separate orders will be issued by the Ministry of Defence and Ministry of Railways, respectively.
6. In so far as the persons serving in the Indian Audit and Accounts Department are concerned, these orders are issued in consultation with the Comptroller and Auditor General of India, as mandated under Article 148(5) of the Constitution of India.
